LWVMC Board Meeting Minutes September 9, 2016

- 1.0 President Cheryl W called the meeting to order at 12:37.
- 2.0 The agenda was approved as amended, with three additional items.
- 3.0 Minutes of the June 27 Board retreat were approved (Lynda L/Amy D)
- 4.0 Cheryl W posed the question for the day: How are state initiatives and referenda numbered?

5.0 Executive reports President:

- 5.01.1 Cheryl announced LWVWA wants volunteers to proof read the Voters Guide. Pat C. and Amy C volunteered.
- 5.01.2 Cheryl asked if we need a publicity committee. Nancy gave a history of unsuccessful attempts to set up an outreach committee, and has a list of tasks. Donna H asked if this was separate from VP's role. Amy D said we need outreach to the public, so they know who we are, and mentioned the Speakers' Bureau. Cheryl tabled the issue for now but will bring it up later.
- 5.01.3 Cheryl asked if we want to hand out a brochure at the Candidates' Forum with information the proposed Mason County Parks Board and election of board members. After discussion, Cheryl decided to include a discussion of Prop 1 at the October 18 membership meeting, along with ballot initiatives and referenda.
- 5.01.4 Lynda suggested we use the information posted on the LWVWA website for the October discussion of initiatives and referenda, and the state League positions on each. Cheryl added that we should devote a set amount of time to each issue. Cindy S will moderate.

Nancy will send out the meeting announcement, which will ask members to read materials before the meeting, and will direct members to the LWVWA website to print out their own copies.

- 5.02. Poster and advertising: Donna H reported on new member recruitment. Committee members will post a new Leaague poster, developed by Barb P, on community bulletin boards. Donna has a master list of sites for posters. All LWVMC members will be asked to print out copies of a new postcard and send it to friends who might be interested in joining LWVMC. Nancy M will email the pdf so members can print out the postcards.
- 5.03. Member services and TPP. Nancy M passed out the current roster of members and Vote411 materials to be handed out at the membership meeting on September 20. Cheryl asked that TPP information be limited to the email previously sent out, in the interest of time.
- 5.04. <u>Treasurer</u> Pat C reported a 2015-16 ending balance of \$1131.65. She handed out the 2016-17 proposed budget. Most

budget items will remain the same as last year. The new budget was approved (Michelle B/Ruby B).

- 6.01 Ruby B showed the new officers' binders, which were well received. Cost per binder will be \$12.25. Cheryl asked Ruby to make 15 copies so that all Board members will have one. Every member will pay the cost of her own binder rather than take the money out of the budget. Ruby will maintain/update them for as long as she serves on the Board.

- 6.06 Michelle B reported that the Young Voter Registration Project is gearing up for fall, and hopes to register 18 year olds by October 10. The project will focus again on Shelton High School, and will try to get contacts at North Mason. Amy C. will help with contacts.
